

## University of Maine at Augusta Bookstore TEXTBOOK RENTAL TERMS OF AGREEMENT

The University of Maine at Augusta Textbook Rental Program provides students attending the University of Maine at Augusta the privilege of renting selected textbooks for **one** semester/term. In consideration for the privilege of renting textbooks, I agree to the following terms and conditions:

1. I understand that rental textbooks are the property of the University of Maine at Augusta. To rent a textbook, I must **pay the rental fee with a credit card**. By accepting the terms of the Textbook Rental Program, I agree to return the rented textbook(s), **including all CDs and other component parts**, to the University of Maine at Augusta Bookstore in good, undamaged and rentable condition and without excessive highlighting, underlining, or marking, by 4:30 p.m. on the semester's Return Date. **The Return Date for any Summer term textbook is the Monday following the last day of my class (as indicated on my receipt).**
2. I am responsible for the rented textbook(s) **risk of loss** for any cause including, but not limited to, loss or theft, fire, missing component parts, fluid or spine damage. I must notify the UMA Bookstore prior to 4:30 p.m. on the semester's Return Date, and in any of those events I will be responsible for the replacement price of the rented textbooks.
3. I agree that all identifying stickers/labels on rental textbooks must remain intact and will not be removed, altered, or obliterated.
4. I understand that it is my responsibility to return my rented textbook(s) to the University of Maine at Augusta Bookstore **no later than 4:30 p.m. on the semester's Return Date, which is indicated on my rental receipt. I understand that if I fail to return my rented textbook(s) by the deadline, I am responsible for payment of the replacement price (also indicated on my receipt) for the textbook(s) plus a \$25 late fee per book.** I authorize the UMA Bookstore to place these charges on the credit card I used to pay the initial rental fee, unless I pay the replacement charge prior to that date. Payments for replacement costs cannot be made with any form of Financial Aid (loans, grants, scholarships, third party accounts, etc.). If I ask someone else to return my rented textbooks and they fail to do so by the Return Date for any reason, I remain responsible for the replacement price of my unreturned textbooks. If I ship my rented textbooks to the UMA Bookstore, I understand the shipment must be postmarked no later than the semester's Return Date. I also understand that if I fail to return my rented textbooks on time, my privilege to rent textbooks from the UMA Bookstore will be revoked.
5. If I fail to pay the replacement price and late fees when due for any reason, I understand and authorize the University of Maine at Augusta to place my student records on hold, which will **restrict me from registering for classes and restrict my transcripts from being released.**
6. I understand that refunds for textbook rentals are subject to the same refund policies as those which apply to textbook purchases.
7. I have inspected the textbook(s) chosen by me to rent, and I agree that they are in rentable condition (no torn covers, all pages intact, no water damage, no excessive highlighting or writing, etc.).
8. **I have read and fully understand the provisions and terms of this agreement and agree to be bound thereby as evidenced by my signature below.**
